Milfoil Program Season

This summer the BRCA's Milfoil Program is in full gear. We have hired twenty-three Courtesy Boat Inspectors (CBIs) to staff the seven boat launches throughout the Belgrade Lakes Watershed. Each inspector is wearing a yellow CBI shirt and will be at each boat launch at various times every day of the week through Labor Day. So far this year, we have had three "saves". This means that Variable milfoil has been found on three boats (all leaving Messalonskee Lake) and removed by one of our CBIs. These saves are the key reason why we employ CBIs throughout the summer. They are our first line of defense against the spread of invasive aquatic plants. If you are out on the water this summer, please be sure to check your boat, trailer, jet ski, and fishing equipment each time you enter the water and come out. It takes three minutes or less and can save years of invasive aquatic plant management.

Our second line of defense is our early detection program which is done by surveying all of the lakes in the Belgrade Lakes Watershed through Invasive Plant Patrols (IPPs). If an infestation is detected early, it will be much easier to manage than one that goes unchecked for years. These IPPs are mostly done by volunteers. Previous experience is not necessary. If you would like to learn to identify invasive aquatic plants please join one of the Eyes On the Water (EOW) workshops happening around the watershed this summer. Eyes On the Water plant paddles are a fun, user-friendly way to learn how to identify invasive aquatic plants. If you are interested in joining an Eyes On the Water plant paddle, or if you would like to help with any of the IPPs scheduled this summer, please call Toni @ 215-2685 or e-mail brcamf@belgradelakes.org. The final piece of the BRCAs Milfoil Program is plant management. This summer there are increased efforts to battle the Variable milfoil infestation in Great Pond and the Great Meadow Stream. The Belgrade Lakes Association launched a STOP Milfoil Campaign and has a goal to raise \$500,000 over the next three years to fund this battle. The BRCA is the organization tasked with carrying out the field action plan for this campaign. So far this summer we

have hired a four person Milfoil Crew to remove Variable milfoil from Great Meadow Stream and the mouth of the stream in Great Pond. This crew will be working until late August. A two person Survey Crew has also been hired to help contain the infestation and to survey other areas of Great Pond as well as Long Pond where more infestations are likely to occur. So far, no new infestations have been found. A professional dive crew, New England Milfoil, has been hired to use their Diver Assisted Suction Harvester (DASH) to remove Variable milfoil from the mouth of the Great Meadow Stream and deeper areas within the stream. They will be harvesting Variable milfoil until about the second week in August. Also, a contract with the Maine Warden Service has been created to hire Wardens on their days off to provide coverage in the North Bay area of Great Pond. Their main goal is educate boaters and anglers about the Variable milfoil infestation. Early in May a surface use restriction (SUR) was placed on Great Meadow Stream and the mouth of the stream in Great Pond to restrict any boaters from travelling through the infestation. The Wardens will also be making sure that the SUR is being followed as this is a critical piece in preventing the infestation from spreading to other parts of the lake. To date almost 7,000 gallons of Variable milfoil has been removed from the Great Meadow Stream and Great Pond. If you would like to learn more about the efforts to battle the Variable milfoil in Great Pond, there will be a public meeting at the Maine Lakes Resource Center on Tuesday, July 17th at 6pm. Tuesdays and Thursdays are also volunteer days, so if you are interested in helping out, please call Toni at (207) 215 -2685.

Efforts are also underway to manage some of the Variable milfoil in Messalonskee. There are a few areas that will be managed using divers and a DASH boat for one or two weeks this summer. Some of the milfoil buoys were moved around during the winter and need to be put back in the correct places. If you live on Messalonskee Lake or notice a buoy out of place, please let us know as soon as possible.

President's Column: It's That Time of the Year

This is the busy season for our BRCA staff! Call the office at 495-6039 and you're apt to hear a hurried "hello" compared to the slower laid back "hello, this is the Belgrade Regional Conservation Alliance" that you'll normally hear from Office Manager Mary Kerwood. Stop by the office for a visit or chat and you'll likely find a lonely office, or if any of our full time staff of four happens to be present, they may just be too busy to talk. Please be patient; they're busy running our programs dedicated to support our land and lake trusts that our members support with their donations.

Our Executive Director, Charlie Baeder, has a myriad of tasks to perform, including supporting our Youth Conservation Corps and Milfoil programs. Or he may be working on the implementation of the Long Pond 319 Watershed Grant, or writing a new 319 Grant proposal for East Pond. He may even be working on a new land acquisition to bolster the over 8000 acres that we've already preserved for public use. That's all in addition to other duties such as managing personnel issues, planning for this year's AQUFEST and Wooden Boat Show, and fundraising. Charlie admits that as a former BRCA board member and president he had a "bird's eye view" of the job, but now that he is the new Executive Director, he has to "work the weeds, or get into the details." Every day he asks himself "where can I be most effective?"

Toni Pied, our Milfoil Coordinator, will probably be busy managing the scheduling of invasive plant patrols or coordinating the 23 employees who perform Courtesy Boat Inspections on all seven Belgrade Lakes. She also manages the massive effort to control invasive milfoil in Great Meadow Stream and Great Pond. Toni concedes "I can't be in ten places at one time, and there are many logistical challenges associated with running these programs." If she's not in the office, Toni is probably out in Great Meadow Stream assisting in the removal of milfoil.

Clark Freeman, our Youth Conservation Corps Director, if not out on one of the lakefront properties supervising his dozen or so employees installing a rain garden, buffer, or other measures to protect our lakes, will probably be on the phone scheduling another site visit or ordering materials. Clark laments that his biggest challenge is "keeping homeowners happy; no detail is too small."

Mary Kerwood recently completed an exhaustive financial audit; we watch every single dollar donated to us to ensure that we get the maximum benefit. She also supports Clark and Toni, and is Charlie's "go to person." Mary is responsible for a multitude of tasks, and is often the first contact for office visitors. She laughed when she recently told me "you just never know who will walk through the door with questions."

Lien Sardiñas, an Americorps, joins us this season as our joint Education Director with the Maine Lakes Resource Center (MLRC). Clark, Toni, Mary, and Charlie are also instrumental in developing and implementing our active Education/Outreach Program.

They also work closely with all five lake associations, the MLRC, Colby College, and Maine Congress of Lake Associations (COLA). I'm convinced that teamwork is absolutely necessary for any organization to be successful, and while we have very talented employees, it's the teamwork that allows them to consistently exceed expectations. In addition, the BRCA board of directors and other numerous volunteers also make significant contributions to our programs.

I am privileged and proud to work with this staff of professionals dedicated to implementing our mission; conserving the lands, water quality, and natural heritage of the Belgrade Lakes Watershed. But without the donations from our members, these wonderful people could not make the BRCA a success. Thanks to all of you, employees, members and volunteers! Executive Director's Column

July 3, 2012. Sunny Belgrade Lakes, Maine. After nearly one foot of rain in June. This is show time in the Belgrades and Belgrade Regional Conservation Alliance (BRCA) is busy at work throughout the watershed. Please excuse the overview below, but I want you to be up to date on new programs we have underway, on our existing programs, and on how your funds are being used.

• Milfoil is the priority program of the summer and Page 2 the outbreak on Great Pond is garnering atten-

- tion, funding, and work. BRCA crews are pulling milfoil in Great Meadows Stream and are surveying the shores of Great and Long Pond. This work is being financed by Belgrade Lakes Association (BLA). BRCA's staff is managing the work.
- Another key milfoil strategy is having a professional dive team pull milfoil with the assistance of a DASH boat in North Bay of Great Pond, near the Great Meadows Stream outlet. BRCA's new milfoil director, Toni Pied, is managing that effort, again in cooperation with and with funding from BLA.
- In addition to limiting the spread of current infestations,
 BRCA continues to fund, staff and manage the Courtesy

Boat Inspector (CBI) program, in cooperation with watershed lake associations, to *prevent new infestations*. Staff and volunteers man the boat launches on all area lakes to prevent incoming and outgoing boats from carrying and spreading invasives. This collaboration with our lake association friends in running the CBI program is one of the key activities of our Lakes Trust.

- Likening milfoil and invasives to an acute condition, as in a heart attack, the other key water and lake problem we are working to make better is a chronic problem which has been building for decades, think type II diabetes: phosphorous-loading. The "P" word. P-loading as a result of soil erosion and other inputs (eg, septic systems) is directly related to algae blooms.
- Our Youth Conservation Corps, managed by second-year director Clark Freeman, works with lake shore land owners to install Best Management Practices (BMPs) such as buffers and rain gardens on their properties to reduce soil erosion, and P, into lakes and streams. Clark is still lining up new projects for summer 2012. Please call or email him soon if you have a project in mind. We provide cost-sharing funds to land owners as an incentive to get projects done.
- We have one other major soil erosion reduction program. We are in the second year of a two-year

Americorps Environmental Educator

grant from EPA and the Maine Department of Environmental Protection, known as the "319 program" of the Clean Water Act. The program provides funds to towns, land owners, and camp road associations to improve roads to reduce soil erosion and P-loading to water bodies. We have some remaining funds available for Great Pond and Long Pond for summer-fall 2012 for both Road Maintenance Plans and for road construction projects. If you have a project idea, please call or email me to discuss. We provide cost-sharing funds to land owners as an incentive to get projects done.

- The last major program we run is where our roots are: land conservation and land stewardship through our Land Trust. We have conserved over 8,000 acres throughout our watershed and are actively pursuing several new property additions. Most of these are open to the public and several have hiking trails. Please get out and use them and contact us and our website to get map and access information
- We have numerous education activities this summer in our new home at the Maine Lakes Resource Center in downtown Belgrade Lakes. We are also running recreational and interpretive activities on some of our properties. Please visit us here, or online at www.belgradelakes.org, to get more information.
- Finally, we are requesting that anyone who has an interest in any of these programs and would like to volunteer, please call or email Mary Kerwood, our office manager, to discuss opportunities. We want your help in getting things done and your enthusiasm in protecting our land, water, and natural heritage.

As you can tell from the above recitations, I'm off to a busy start here as executive director. I thank Pete Kallin for leaving BRCA in good shape, and thank my staff for doing a great and dedicated job. With that in mind, I gotta go.

Conservation Corps 2012 Season

The start of summer means the start of another busy season full of conservation projects for the BRCA Youth Conservation Corps. This will be the Corps 17th season and we are hoping to complete our 800th project. We will be busy working on all 7 lakes/ponds in our watershed, helping to improve lakeside properties with chronic erosion problems. Our mission is to reduce the amount of soil washing into water bodies during storm events. Soils carry phosphorus which cause increased plant growth or algal blooms in watersheds reducing water clarity and recreational appeal.

To repair these erosion sites we have hired 12 local high school and college aged students from throughout the watershed to implement different Best Management Practices (BMP) for storm water.


