# President's Column: Thank you BRCA Volunteers!

This month's column is dedicated to all the volunteers who spend countless hours working to preserve our lakes and watershed. I will not mention any names because there are far too many and undoubtedly someone would be left out. Without volunteers the BRCA would not be as successful as we've been. We have 3-4 full time paid employees, depending upon the time of year, and they will be the first to tell you that they could not do their jobs as well as they do without volunteers.

There are two types of volunteers; planners and doers. Without the planners our efforts would not be very effective. The old saying goes; if you fail to plan, then plan to fail. But without the doers to carry out the plans nothing would get done. Fortunately for us, many of our volunteers are both planners and doers.

Our volunteers work on a wide variety of tasks consistent with our mission and strategies. So what do these volunteers do?

Milfoil The BRCA obtains funds from the state, the towns lying in our watershed, and the five lake associations to hire Courtesy Boat Inspectors necessary to reduce the risk of invasive plants entering our lakes. But we can't afford to cover all the critical hours at our boat landings. Fortunately volunteers fill much of this gap. They also pitch in when we do our annual Invasive Plant Patrols at the boat landings where we canvas the high risk areas for signs of invasive plants.

When variable leaf milfoil was discovered in Great Meadow Stream several years ago leading into Great Pond, the volunteers poured out in droves from all five lake associations. Many helped construct benthic barriers that could be laid on the bottom of the stream and lake to cover patches of milfoil, effectively killing the plants. Others helped install the barriers in the lake, while some actually climbed out of their kayaks into the muck of the stream and hand pulled the milfoil, all under the close supervision of our experts.

**Water Quality** The LakeSmart program developed by the Department of Environmental Protection has gained tremendous support on some of our lakes. LakeSmart is a program that offers

free opportunities for homeowners to learn how to manage their home and yard to improve water quality in their lake and maintain the value of their shorefront property. Unfortunately the DEP lacked the funds to hire the necessary people to perform the LakeSmart evaluations requested by many lake-front owners. Today volunteers do most of the LakeSmart evaluations in our watershed!

Land We also have volunteers who help maintain trails as well as construct new trails on the 8000 plus acres that the BRCA has preserved in our watershed. Our Stewardship Committee, all volunteers, plans these activities and ensures the plans are executed. If you haven't hiked our new trail on The Mountain (built by volunteers), you're missing a real gem. It ties into the old trail and has wonderful views of Great Pond. We also have volunteers who manage our land acquisition program and bring recommendations to the BRCA board to consider. Currently we are working on several land deals that will be handsome additions to the Kennebec Highlands.

**Education** Volunteers plan and carry out our Education program. They organize many of the lectures held each summer in the Maine Lakes Resource Center (MLRC) along with field trips throughout our watershed. Most of these outdoor programs are led by volunteers. Aquafest, a bi-annual family event, is run mostly by volunteers.

**BRCA Board** Lastly, there are 13 members on the BRCA board of directors, excluding myself. Each possesses unique skills and works very hard to ensure that we meet a high standard. I am truly impressed with their professionalism and commitment to making good decisions.

I've mentioned only those volunteers who support the BRCA. There are many more, often the same people, who also support the MLRC, Maine Lakes Society (formerly COLA), and the five lake associations. I could probably write several more pages on our volunteers, but I hope you get the message; without volunteers we would be a much less effective organization. I look forward to thanking many of these volunteers at our annual meeting on September 3 at Alden Camps on East Pond. I hope to see you there.

In 2010 variable milfoil was discovered in the Great Meadow Stream and Great Pond. Since that time, efforts have been underway to contain the infestation and remove the plants. 2013 marks the second year of the Belgrade Lakes Association's STOP Milfoil Campaign. BRCA has been tasked with implementing the action plan for this campaign. This summer, New England Milfoil (a professional milfoil mitigation company) is back for nine weeks, using their diver assisted suction harvester (DASH) to remove the large patches of variable milfoil plants. Four college students have also been hired to hand pull plants in the stream and the three other tributaries that were discovered to have variable milfoil plants.

There is also a two-person survey team that is combing the shoreline of both Great Pond and Long Pond looking for any other new infestation, as well as a two-person outreach team that will be conducting Adopt-A-Shoreline trainings and going door-to-door talking with folks about the threat of invasive aguatic plants and how they can help.

Due to a matching grant secured by the BLA, each new contribution will be matched two to one, and if you have contributed in the past, your dollars will be matched one to one.

For many years Messalonskee Lake and the Belgrade Stream have been infested with variable milfoil. With financial assistance from the Towns of Belgrade, Sidney and Oakland, the State of Maine, the Belgrade Lakes Association, the Friends of Messalonskee, and the US Fish & Wildlife Service North American Wetlands Conservation Act small grant program, BRCA will make efforts to remove variable milfoil from certain parts of Messalonskee Lake and Belgrade Stream. \*Salmon Lake, Eurasian milfoil update: Early in June, The Department of Environmental Protection surveyed Kozy Cove on Salmon Lake and did not discover any Eurasian milfoil plants. A few more surveys will be done throughout the summer to monitor the cove.


#### "The New TRAIL" on "The Mountain"

"THE NEW TRAIL" is the only name we have yet for the latest path on "The Mountain". It has quickly become a favorite of morning walkers, their dogs, and an early a.m. runner or two.

This new path branches off the original "Mountain Trail" on the Great Pond side describing an outer perimeter of the old "Mountain Trail". Instead of open vistas, one is treated to branch-framed overlooks of Hoyt's Island and the open reaches of Great Pond. The path passes moss-lined ledges and a wonderful mature hemlock wood. If you carry on counter-clockwise, you'll cross the woods road and continue on the path towards Long Pond. Crossing the woods road again, you'll follow your nose until you find yourself back on the original trail, at which point you can choose left towards the car park, or, right down the original path, past the Long Pond ledges, and then down to where you started.

The trail has a surprise or two, plus one "standing stone" looking like the fickle finger of fate award. Watch your feet as this is not a level trail. Besides travelling up and down, it slants sideways in spots. Sling-back pumps are probably not a good choice of footwear. "The New Trail" is a beautiful, quiet, peaceful way to spend an hour or two.

# Watershed Protection Grant Project Completed by Cornville Regional Charter School Students and NPA Volunteers

A DEP Watershed Protection Grant Program provided funding and classroom support for a service learning project designed to protect the water quality of a lake or stream and to educate the public about the relationship between land use and water quality.

Cornville Regional Charter School 5/6 grade teacher, Ashley Leslie, took advantage of the opportunity to work with the North Pond Association to have students learn all they could about the subject then put what they learned into action on a steep, eroding slope on Lake View Drive in the Smithfield.

The DEP's, Leslie Latt, prepared students for the upcoming project in the classroom where she lead discussions about watersheds, erosion, buffers, phosphorous and the damage it can do to a lake and other bodies of water. They also helped demonstrate the cycle of rain water using sponges and spray bottles in the watershed model complete with mountains that Ms. Latt shared with them. The demonstration was a

great example of just how easy it is for pollutants like naturally occurring phosphorous, to flow into a body of water. They learned buffers found on the edge of bodies of water can help stop phosphorous with their root systems and slowing down the flow of the water is the key to filtering out the phosphorous.

The Youth Conservation Corps helped out by spreading erosion control mulch over burlap to help stabilize the soil around the plants and discussed a more permanent plan for the future of this very steep site. (see photo on back page)

Students will present their experience one evening this summer at the Fairview Grange in Smithfield. The date announcement will be made on North Pond Association's FB page and on <a href="https://www.NorthPond.net">www.NorthPond.net</a> and in Summertime in the Belgrades. There is a sign at the site of this successful service learning project so be sure to check it out!

#### **Executive Director's Column**


We are in our 25th anniversary year and we will be celebrating several times this summer. First, is an Open House at the MLRC this Saturday, July 6, from 1 -4 PM. Next, is the bi-annual Harold Alfond Memorial Pro Am Golf Tournament at the Belgrade Lakes Golf Club on Wednesday, August 14, an important fundraiser held in support of BRCA and lake association water quality programs throughout the Belgrade Lakes watershed. Finally, we are holding our annual 5K race on Saturday, August 31, and our 25th BRCA Annual Meeting at Alden Camps on Tuesday, September 3. We hope to see you here!

Land Trust We have several land trust deals under discussion, and two under contract, at this time. Because of their confidential nature, the details are yet to be publicly announced. One is an addition to the Kennebec Highlands, one is in the Rome hills, one is on Messalonskee Lake, and two are on Salmon Lake. BRCA is increasingly looking at land deals that protect water quality and wildlife, in addition to expanding existing holdings and providing recreational opportunities for our members and the community. We expect to be able to publicly announce several of these deals this year.

Rome Cell Tower The BRCA board believes the cell tower issue is important to the investment our members have made in land conservation, and has taken a proactive advocacy position with the Town of Rome in regard to the application.

BRCA Conservation Corps Truck Many thanks to Central Maine Motors, and owner Chris Gaunce, for providing the Conservation Corps a free truck for the 2013 field season. This is the second year that CMM has provided BRCA a truck for the conservation corps. It is needed and is greatly appreciated! Many thanks as well to Friends of Messalonskee president (and BRCA conservation corps board member), Wally Buschmann, for helping make this CMM connection. Water Quality Steering Committee On June 24, BRCA met with representatives of area towns, businesses, lake associations, and community members to discuss Water Quality issues in the Belgrade Lakes watershed. This meeting was organized by BRCA in order to address long-term water quality declines in

the watershed as documented in the 2009 Long Pond Watershed-Based Management Plan, approved by Maine DEP and US EPA. The document is a call to action to reduce phosphorus-loading to area lakes. The Steering Committee is developing a Mission Statement and will be organizing working groups to address the challenges raised in the management plan. A copy of the plan will soon be available for download on the BRCA website. #### Milfoil 2013: Season No. 13

Last year, the BRCA's Courtesy Boat Inspectors (CBI) inspected almost 12,000 boats throughout the Belgrade Lakes Watershed. Since 2002, the BRCA has been coordinating CBIs at each of the watershed's seven boat launches. You can't miss their bright yellow shirts and enthusiasm for protecting the lakes from invasive aquatic plants. So far this summer, there have been two "saves" coming out of Messalonskee Lake at the Sidney boat launch. A "save" means that a CBI pulled an invasive aquatic plant (variable milfoil in this case) off a boat or trailer either going into the lake or coming out. In both cases, the plants came off a boat/trailer coming out of Messalonskee Lake, which is known to have variable milfoil.

Thank you to Cameron Dick and Renee Dugal, responsible for the saves coming out of Messalonskee, for their vigilance and dedication to our CBI program and thank you to all of our CBIs for their hard work so far this summer!

Adopt-A-Shoreline is a new initiative that has launched this summer. This program is a collaboration between the Belgrade Regional Conservation Alliance (BRCA) and the Belgrade Lakes Association's STOP Milfoil Program, to stop the spread of milfoil in our lakes. The program, modeled after the popular Adopt a Highway concept, will teach residents to monitor their own shorelines for invasive plants including variable milfoil. The BRCA is providing training in identifying milfoil to empower people to help

track the spread of this foreign plant. Adopt a Shore-line is open to any lakefront property owner or group and is an excellent opportunity for local road associations to become more involved in their watersheds. #### **Cell Tower Process in Our Viewshed**

The BRCA board believes the cell tower issue is important to the investment our members have made in land conservation, and has taken a proactive advocacy position with the Town of Rome in regard to the application. The BRCA, through its Executive Director, Charlie Baeder, and its President, Mel Croft, has been actively participating in the review by the Rome Planning Board of an application to site a cell tower on The Mountain, between Long Pond and Great Pond. Late last year, Global Tower Partners, LLC (GTP) submitted a land use application to the town of Rome, seeking to erect a 190' wireless cell tower on property not far from the BRCA trails on The Mountain and visible from trails on French Mountain and Mount Phillip. After reviewing the application and the Rome Telecommunications Facilities Siting Ordinance, we took the position that the application was incomplete in that it totally failed to address several key requirements of the Ordinance including the visual impact of the proposed location, the effect on property values in the surrounding areas and an examination of alternatives to the proposed location. Additionally, we provided information to the

Planning Board that the Application violated the Ordinance in that it did not comply with setback requirements and several other essential features of the Ordinance.

In support of our efforts to ensure that the Applicant comply with the requirements of the Ordinance, particularly the visual impact requirement, we commissioned DeWan and Associates to prepare a visual rendering of the proposed tower and show its impact on the views from several BRCA locations, including French Mountain and Mount Phillip, as well as the impact on the view from locations on Long Pond and Great Pond. Those visual renderings are also available.

The Planning Board held a public hearing in May and had further discussion at its meeting in June. They are scheduled to consider the Application at their July meeting scheduled for 7PM on Monday, July 8<sup>th</sup> at the Rome Town Hall on Mercer Road. Charlie, Mel and other members of the Board will continue to participate in the process, but if you would like to weigh in on the impact the proposed tower may have on you, please send a letter to: Rome Planning Board, Town of Rome, 8 Mercer Rd, Rome, ME 04963.
